

## 2021 QUEEN/PRINCESS CONTRACT

Welcome to the 2021 SIJRA Queen/Princess Contest. You should have already received, reviewed and filled out the application if you are interested in competing for a 2021 royalty spot. Please make sure that gets turned in at the Announcer's Booth by the end of the rodeo on September 19th

This Contract is a binding agreement for those who are crowned 2021 royalty. Those who are chosen as 2021 Queen or Princess must be able to abide by all of the rules, regulations and expectations as follows:

1. Contestant must be a current SIJRA Member as defined in the 2020 By-laws and Rules to compete and must continue to be a current, defined SIJRA Member through the 2021 season.

2. The role of Queen/Princess is not an event in and of itself and therefore The Queen/Princess titleholder must participate in at least one rodeo event for her grade division at each rodeo throughout her reigning Season.

3. The Queen/Princess titleholder agrees to attend and fully participate in all mandatory events. These events include, but are not to be limited to:

- a. The 2021 Membership Meeting. Generally held in March either at the Arena or a location as determined by the Board, with specific dates to be determined.
- b. All 2021 rodeos at the Kalmbach Arena, including Grand Entry.
- c. The year-end banquet, which is generally held in January of the following year (2022) to hand out awards and take pictures. Royalty must be present at a time designated by the Queen Chairperson to assist with the next year's contestant Speech and Interview contest.
- d. Any other events the Board sanctions to be part of the Queen/Princess role with sufficient notice to be given to the Queen/Princess in advance.

4. Should the Queen/Princess titleholder be unable to attend an event or carry out her specific duties, she must notify the Queen Chairperson well in advance of the event to make arrangements. If there is not a valid reason as to why the Queen/Princess cannot uphold her duties, she may be subject to reprimand.

5. The Queen/Princess titleholder agrees to uphold a high level of standards in and out of the Arena. This includes any event at the Arena grounds, any event sanctioned by the

SIJRA Board, and also any events away from the Arena (school, etc.) These standards include, but are not to be limited to:

- a. Be encouraging and supportive with other Members
- b. Exhibit good sportsmanship at all times
- c. Be respectful and free from drama
- d. Free from suspensions/expulsions/reprimands at school
- e. Always representing SIJRA in a positive light
- e. Any other standards the Board may deem necessary.

6. The Queen/Princess shall uphold the same standards and represent SIJRA in a positive light while she is attending/competing in other non-sanctioned events, such as Hoosier Horse Fair, North American, clinics, etc.

7. The Queen/Princess titleholder may be reprimanded by the Queen Chairperson or a Board Member at any time they feel she is not upholding these standards. Should there be a second occurrence (or depending on the level of reprimand for the first occurrence) the Board has the right to revoke the Title and/or impose other sanctions.

## PARENT/GUARDIAN DUTIES OF QUEEN/PRINCESS TITLEHOLDERS:

8. I understand that as the parent/guardian of the Queen/Princess titleholder, that I will have duties as well during her reign. Those duties include, but are not to be limited to:

- a. helping with the Sponsorship Flags at each Grand Entry
- b. making sure the Queen/Princess titleholder is at each mandatory event on time
- c. any other duties as determined by the Queen Chairperson/Board.
